DAYS 1-2

Intro

Prompt-level work and habits for useful first passes.

DAYS 3-7

Intensive

Attorney-led agentic workflows.

DAYS 8-10

Capstone

Coordinated agent teams. Included only inside MasterClass.

PROGRESSION | DAYS 6-10

From the hearing record to an attorney-led practice system

The Intensive closes with people and decisions. The nested Capstone moves into coordinated agent teams.

CAPSTONE | DAYS 8-10 Included only inside MasterClass.
